



Butterlaw is a small rural hamlet which lies 4 miles to the North of Coldstream. Coldstream is referred to as "The first true border toon" as it is located just over the River Tweed which acts as the physical border with England. The town boasts a variety of amenities including shops, pubs, cafes and recreational pursuits such as golf, tennis, beautiful riverside walks and of course fishing. Primary schooling is offered in the nearby village of Swinton (3 miles) with Secondary schooling at Berwickshire High (8 miles). More extensive shopping and recreational facilities can be found in the coastal town of Berwick-upon-Tweed (12 miles). Here there is also an east coast mainline train station and the main A1 road offering superb transportation links to the North and South.
